The 62,004 hectares dedicated to garden coffee produce on average around 20,000 metric tons of Yirgacheffe washed and sun-dried coffee per year.

It is organic and Fair-trade certified coffee producers and exporters.



Kafa Forest Coffee Farmers

is originated. KFCFCU was
established in 2004 by 17 primary

Currently, the number of member cooperative societies has reached 55 with more than 13,676 smallholder members (about 20% female) and its net asset has reached over 103 million birr.

The main purpose of its establishment is to export Kafa coffee to the international coffee market so that farmers get a better price for their product and improved livelihood.

The union also has a mission to promote the origin of coffee.

Naturally organic coffee, wildgrown coffee in a multi-layered upland rain forest, superior product for national and international markets, traceability of the product, a direct link to the international market, and payment from the net profits as dividends to farmers is the uniqueness of the union.

In addition to the marketing of coffee, the union has also been involved in building capacity of primary cooperative societies & farmers; participating in the establishment and provision of social and economic infrastructures; playing a leading role in the effort to conserve natural resources especially natural forests.

The natural resource and environment conservation activity is the core activity to preserve the origin of coffee Arabica Kafa.

Sidama Coffee Farmers Cooperative Union (SCFCU) was founded in 2001 to represent coffee producing cooperatives located throughout the sidama region in Ethiopia.

Today, SCFCU represent 68 cooperatives and over 70,000 farmers (smallholders) making SCFCU the second largest coffee producing and exporting cooperative union in Ethiopia.



Situated in Tetu sub-county,
Gathaithi village, it was established in 1967, then being under the larger Tetu cooperative; in June 2000, it was registered autonomously. It currently has one wet mill with a total membership of 1783 active members with a total number of 230,000 coffee trees giving a total average of 870,700 kgs of cherries annually.

In 2022, Gathaithi FCS was featured in the U.S based (San Diego, California) Jaunt coffee roasters, coffee review having scored 93 points with a balanced floral-toned Kenyan cup with distinct notes of black currant, a pleasing savoury fruit attribute often associated with classic Kenyan coffees.

In 2024, it emerged second nationally by paying its members 126 Kenya shillings per kilo of cherry delivered, a milestone achieved courtesy of ARABIKA project interventions and positive reception and project ownership by her board, as well as supervisory committee members.

Situated in Gatundu sub county, on the slopes of the Aberdare mountains, in an altitude of 1700-1900 metres, hence the suitable growing conditions for Arabica Coffee variety.

It was registered in 1995, after a split from a giant society named Gatundu FCS, specifically Ichaweri, Ritho, Muhara and Gitwe.

After the split, Gitwe FCS continued to grow in membership and came with by-laws, with the main objective of the society being to promote the welfare and economic interests of its members, in accordance with the cooperative principles, among others such as voluntary & open membership, Democratic member control, education, training and information, autonomy & independence, Communities welfare.

It is a community-owned factory that processes coffee cherries and sales on behalf of its farmers.

The cooperative is situated on the slopes of Mt. Elgon and neighbours Cheptais Forest.

The cooperative was constructed in 1998 and started operations as a subsidiary of Emanang FCS in 2002 and was fully registered as a cooperative on 9th September 2011.

The factory was established in 1998 as a way of bringing coffee services closer to coffee farmers in the highlands of Cheptais Forest as previously farmers were taking their coffee cherries to neighbouring factories.

The factory started with membership of around 200 and has expanded to current 3001 members consisting of 936 women, 2065 men and 471 youths.

Its mission is to operate as a member-owned and membercontrolled institution offering high quality services/production to its clients.

Located in Tigania East sub-county, the society area of operations is along the slopes of the Nyambene Forest, an extension of Mt Kenya Forest.

The soils are made up of volcanic soils, making the area ideal for farming.

The FCS was registered in March 2006, consisting of two factories to promote the economic welfare of the members, with the aim of enhancing better & increased production, better processing standards and marketing their high-quality coffee.

Total active membership is 4615 registered small-scale farmers (2644 women, 4838 men), practicing mixed farming with coffee as the main cash crop.

Located in the Runyenjes Sub County, it was established in 1978 after a split from the greater Kyeni FCS (called old Kyeni).

The cooperative consists of 1520 active member affiliated to four factories, with an average yearly production of 350,000 kg of cherries per year.

The cooperative is in a good climatic region, rich with volcanic soil from the slopes of Mt. Kenya, in an altitude of 1500 m above sea level. New Kyeni coffee has medium acidity, giving it complex and intense flavour and a unique aroma.

Currently majority of New Kyeni coffee is being maintained by women and youths as elderly men are increasingly dividing their coffee farms and offering coffee trees to their wives' and children to continue the coffee farming tradition.

The cooperative is situated in Kathiani sub-county at an altitude ranging between 1850 m - 2125 m above sea level. It comprises of 2 coffee factories owned by 1200 small scale coffee farmers with about 287,327 coffee bushes.

The 2022/2023 production was 73,000 kgs of clean coffee; 120,000Kgs coffee harvest is projected for the 2024/2025 period.

Agriculture is the backbone of Kaliluni a farmer's economy. They have created opportunities for women and youth in day-to-day activities. These have contributed to increased income, raising their standard of living.

The society supports farmers in practicing sustainable farming, protecting the natural environment and managing natural resources through proper agricultural practices.

The Cooperative is a 1st grade Fairtrade Certified organization.



The society is in Munithu Location – Nkobo centre/village, Imenti North sub-County, that covers Mirigamieru East and West & is made up of 7 factories with 11 permanent staff.

Nyaki Fcs is one of the smaller coffee cooperatives in Meru with a total number of 755 active farmers, made up of 425 men, 290 women & 40 youths.

Most of the small holder farms are spread in an altitude of approximately 1800m above sea level with an average rainfall distribution of 500 – 700 mm per annum.

BOCU is formed of 13 primary Cooperatives that comprise of 4,102 small holder coffee farmers living on the hills of Mount Rwenzori.

These farmers are organic, Fair trade, GI and are in the process of acquiring Rain forest Certification.

The farmers process their coffee at micro BOCU has the potential of producing 22 coffee containers of certified coffees but because the buyers are still limited we are able to sale 12 containers a year and they are sold as micro lots.

We have sold to EZA in Austria, utamtsi in Germany, Supremo in Belgium.

Our coffees score ranges between 84 – 86.25.coffee washing station and deliver to the union as micro lots and sale micro lots.
